# Council Highlights

### Training

In 2019-2020 the Training Council provided numerous trainings for our members, including our first GMM via Zoom. It went surprisingly well! Training Committee planned 64 trainings, including a behind-the-scenes tour at KC Rep, an interior decorating lesson and a financial retirement course. We were pleased to welcome some of our community partners to various trainings. While our Missouri Advocacy Day was cancelled because of COVID-19, we joined our Kansas sister Leagues for Advocacy Day in Kansas. We planned an amazing final Civic Leadership event featuring Jackson County Prosecutor Jean Peters Baker, and while we had to cancel it this year, we're excited to bring this event back next year. Our Sustainers educated (and delighted!) us for a panel on strategy for our Strategic Symposium. Additionally, our fearless Sustainer advisor Jane Guthrie started First Friday trainings for Sustainers at Headquarters over the lunch hour, and these sessions were so popular they are now offered to all members for training credit.

### Finance

The Finance & Budget Committee had a fantastic year! We had a successful audit with our new auditors. We are in the process of switching over to a new accounting system that will provide us with greater reporting capabilities and insight into our financials. The Legacy Fund granted \$13,200 to directly fund our mission of training women. They continue to push for our members to "dream big," which resulted in a higher dollar request. The Community Endowment Fund supported community partners throughout the year and provided financial support to a number of nonprofit groups when COVID-19 hit the agencies hard. The Holiday Mart, C3KC and Take Five Business Managers were all able to support the fundraisers in making them a success! We built new relationships and had a great year!

### Membership

The 2019-2020 Membership Council had a successful year because it comprised a group of dedicated women that truly cared about listening to the needs of our members. The Membership Council implemented two significant membership-driven changes:

- Lowered the number of Active years required to participate in Active Gold.
- · Based on feedback from November In-Home meetings, increased flexibility for members by combining the GMM and training credits into one bucket.



This new member group had a great time creating inspirational, motivating signs at one of their meetings!

The Council was very busy ensuring members were engaged and enjoying their League experience. Here are a few highlights from some of the committees that sit on the Membership Council:

### **Dinner Club**

The chairs did a great job coming up with creative and fun ideas for social media, including videos and stories. There were two opportunities to sign up for Dinner Club this year, one in the fall and one in January.

### **New Member Education**

Ninety-seven New Members successfully completed their course requirements.

#### Placement

Due to COVID-19, the Placement Fair was totally revamped to be held via Zoom. This was the first time JLKCMO offered a virtual GMM.

#### Admissions

In 2020-2021, there will be 97 New Members. We initially accepted 103 New Members, but due to COVID-19, 6 women decided to defer membership.

#### **Connections**

Considering the current pandemic, we established Connections Corner virtual events aimed at keeping members engaged and connected at home.

Overall the Membership Council did a great job ensuring members were engaged and making connections with each other!

### Community

### **Amethyst Place**

Amethyst Place is a transitional housing and recovery facility that places a special focus on mothers recovering from substance abuse. Frequently the women are young and were raised around substance abuse themselves. Amethyst Place offers a fresh start for the women and encourages educational attainment and family therapy to help them heal and focus on a healthy future. This League year, the Amethyst Place Committee continued serving as mentors for the organization's EnCompass program, which pairs two mentors with a resident or graduate of Amethyst Place.

Throughout the League year, mentors meet twice per month with their "moms" to model friendship and share a meal during EnCompass. The program emphasizes connection and support as part of a healthy friendship, which helps empower the mom to build coping skills and confidence.

Both Amethyst Place and the EnCompass program had new leadership this year, so we had a chance to build new connections at the agency and continue to show strong League support for the agency's programming.

Although we ended in-person mentorship in March due to the pandemic, we've been able to continue to model friendship and loving care to our moms through email and texting. We were able to contribute to a special Mother's Day recognition by surprising our moms with supportive letters. The best part of involvement in this program is watching the friendships grow and seeing how relationships with our moms endure beyond the League year.

### Wayside Waifs

This year, the JLKCMO provided well over 300 hours of service through January. We helped with 37 programs, serving almost 700 kids and another 700 adults. This was primarily through onsite tours, Kids in Action service projects and a reading program, but also included animal socializing and helping with large community events. Before we were able to lead programs, we learned about Wayside's history and operation, as well as how to safely work with the animals.

### **Jewish Family Services**

Highlights include:

- Over 4,000 pounds of food was donated to families at the JFS Food Pantry, where we volunteered twice a month. This allowed for JFS to offer evening sessions for clients to shop for groceries and pick up food.
- We made food deliveries to homebound seniors, including contactless deliveries during COVID-19.
- We stocked shelves in the free food pantry, as well as helping clients shop (the pantry is set up like a grocery store), providing a friendly and welcoming experience.
- We partnered with Healthy U to have cooking classes and demonstrations for shoppers, teaching how to make a yummy French toast recipe.

We can't wait to work with JFS again next year, now as part of Healthy U.

#### Lazarus Ministries

This year our committee provided volunteers and donations every Saturday prior to COVID-19. We also hosted at-home sorting parties to organize clothing our committee donated to the boutique. Several members also used their personal time to host clothing and food drives, as well as volunteered above and beyond their Junior League requirements. Three committee members also joined the board of Lazarus Ministries this year!

### Sustainer

Our 779 Sustainer members were treated to a year of fun activities, meaningful trainings and plenty of opportunities for fellowship and volunteer service.

Social Chairs Susan Hatten and Teresa Martinez, along with Pam Fleischer, coordinated several beautiful events. These included the Fall Luncheon at HQ, featuring guest speaker Sustainer Elizabeth Williams, who spoke about Gorham Silver... the Winter Coffee at the beautiful home of Past President Mina Steen... Simply Social, featuring a Spring Break theme... and the Spring Meeting, which sadly had to be postponed due to COVID-19. The chairs also coordinated various informal social events at area establishments and called them "601 Socials" (the gatherings started at 6:00, but that wasn't a hard deadline!).

Sustainer Done-in-a-Day events were also "Fun in a Day" this year, thanks to co-chairs Jan Flanagan and Lyn Cravens Wagner. They organized four DIAD events that were well attended and very positively reviewed: Women Helping Women, Tiny Houses, Big Hearts, Pick Your Passion and Flower Power.

Our Interest Groups were a tremendous success, with special events and gatherings on a variety of topics: Bridge, Garden Club, Mah Jongg, Investment Club, Newer Sustainers, Lunch Bunch, Book Clubs, Noteables and Art Blocks.

Sustainer Jane Guthrie initiated a lunch & learn speaker series that became the "First Friday Lunch & Learns." Among the featured offerings were League members training fellow Sustainers on a variety of topics. We are anxious to see this continue, as it was well received, well attended and even welcomed Actives and New Members, who joined us for training credits.

Sustainer Katie Gerson served as one of three co-chairs for C3KC this year, and the Past Presidents together donated \$40,000 to become the Presenting Sponsor of the event.

The Past Presidents also joined current President Katie Werner for a first-time Fall Forum to discuss various topics affecting the League.

Emeritus members enjoyed their annual coffee at Headquarters in October. A visit with Katie Werner sharing an update on current League community projects was a valued addition to the event.

The Sustainer Council brought two motions to the Board of Directors for consideration this year. The first was a revised "Ethics Code" (formerly "Code of Conduct"), which addressed some of the format and wording concerns various Sustainers had brought to our attention. The second was a motion to create a Special Committee that would review ways to make our League archives digitized, easy to access and able to accept recorded historical interviews (video and/or audio). Both motions passed.

Social media continued to play an important part in our communications strategies. We focused on a steady stream of posts not only to the Sustainer Facebook page, but also to the other Junior League Facebook pages (JLKC Members and Junior League Connect), recognizing Sustainers in the community and thanking Sustainers for their contributions to the League. We also started a special Sustainer Instagram page this year and hope to see it grow in followers, as more Sustainers migrate to that platform for their social media connections.

The Sustainer Nominating Committee, led by Julia Sobek, filled an outstanding leadership slate for next year. The Council will be led by Lissa Haag. The committee also chose, and the Board approved, Sustainer and Past President Jerry Vaughan as this year's recipient of the Community Service Award. We arranged for a large lawn sign display to congratulate Jerry, as we were in quarantine due to the pandemic. We look forward to presenting Jerry with her award in the fall. She chose Pathway to Hope as the recipient of the \$1,500 award donation in her name. The Nominating Committee also nominated Past President Audrey Langworthy for the Starr Hall of Fame, which will be officially announced in the fall. Thank you to Acey Lampe for writing a beautiful nomination.

When the COVID-19 crisis hit, approximately 20 Sustainers joined forces to call and check in on Emeritus members. These moments of friendship were appreciated by all, and thank you to everyone for their assistance.

### Sustainer Spotlight

his issue's Sustainer Spotlight features Katherine Schorgl, a Past President of our League. Katherine was an Active member for 13 years and has been a Sustainer for the past 16 years. She's held every about every position in the League that you can imagine and has been an integral part of JLKCMO's evolution throughout the past 20 years.

### So, Katherine, what made you want to join the Junior League?

I had recently moved to Kansas City, and I did not know many people. Some friends from TCU suggested I join, which I did, and I can never thank those friends enough, because the League has given me incredible friendships, training and experiences.

### What were some of your favorite positions you held in the League?

Well, obviously, being the President during 2002-2003 was one of my favorite positions, and the most rewarding job I've ever held within the League. Aside from that, I enjoyed being part of Finance Council, and being the Director of Sustainers. I was also the first Director of Community Impact when we launched Children's Literacy as our first impact area. I can honestly say that I enjoyed and got a lot out of each position I have had in the League.

### What is the best thing about being a Sustainer as opposed to an Active member?

I would have said that it is that Sustainers are not required to attend General Meetings, however, the General Meetings looked so fun last year that honestly, I wished that I was required to attend them!

### What do you wish the Active members knew about Sustainers?

### What advice would you give current Active members looking to become more involved in the League, but are unsure how to go about that?

Consider participating in JL360 and any other leadership training offered. Ask your chair or Council Director for advice on any committees you are interested in chairing in the future, and then you can always submit yourself to the Nominating Committee for the position you want. Even if you don't get it the first time, the effort to submit yourself will show the Nominating Committee that you want to be involved—they will remember that. There are boundless resources in the League for those that want to seek them out—the opportunities are endless!

# Community Service Award

ith pride and affection, we announce that Sustainer Jerry Vaughan is our recipient of the 2020 Community Service Award. For 60

years she has kept her heart in the game, her hands on the work and her eyes on a bright, inclusive future. Jerry's significant impact on the Kansas City community has come from her impact inside the League—her steadfast priorities as a Junior League leader and deeply committed member have helped keep our attention on relevance, improvement and achieving diversity and inclusion. Jerry's North Star has long been, "You can't serve the community unless you're of the community."

Historically there were sizable obstacles to membership in the Junior League, from a secret, deliberative admissions

process to the outright exclusion of women outside a narrow set of norms. The organizational vision and welcoming outlook of leaders like Jerry, however, could see the many limitations that bias brings to the table. She actively looked for ways to open our League so that the world didn't outgrow our reach.

During her tenure as President, Jerry advocated full membership for our professional (i.e., working) members. Prior to the change efforts she undertook with fellow League leaders, these members could not fulfill placements and very importantly could not vote on organizational issues. Within the 1970-1971 League year, however, professional members

could attend a membership meeting the night before regular daytime meetings; for the first time then they had meeting attendance requirements as well as the vote on all issues. That year also brought a professional member onto the voting Board.

Over time Jerry also wisely steered us into new community partnerships. Working together on meaningful goals not only assures better outcomes, but also helps the groups involved see each other as friends, colleagues and peers. Through many decades of support and enthusiasm, Jerry has helped our League members grow not just in numbers but in organizational

intelligence and willingness to act. Her style is to create as well as respond to opportunities for growth and change. And the Kansas City community has steadily benefitted from each of our maturity milestones.

Congratulations, Jerry! Your long-time loyalty to what we are and strong encouragement for what we can be has kept you a vital part of our community impact and service.

### Take Five Chairs Meghann Aberle and Lilly Coye



On March 4, 375 people attended Union Station Kansas City for the third annual C3KC event. C3KC is a collaborative conference for corporate, civic and community stakeholders to spark change for a better Kansas City. 
